



5 steps to the AU summit 2021: Initial plan



Key elements of PIDA PAP2 process

- Learning from PIDA PAP 1:
 - Focus on fewer high impact projects with higher level of readiness
 - Alignment with the Integrated corridor Approach
 - Inclusion of Economic, Job, Gender, Climate and Rural connectivity criteria
- Comprehensive PIDA PAP2 documentation:
 - Analytical note and strategic note developed
 - Task force members trained to master the eligibility and selection criteria
 - Face to face training sessions delivered in February and March to MS and REC focal points in 4 regions
- The Planned PIDA process was disrupted by Mid March by the Covid pandemic, lockdowns and border closures.

Measures to adapt to the pandemic

- Website and fully digitalised process developped for project submission and validation:
- <https://pp2.au-pida.org/> launched on 7th April 2020
- 24 Zoom webinars with RECs and MS facilitated from April to June:
 - To complete training, provide clarifications and address questions
 - Dedicated sessions to deep dive into sectors and themes:
 - Transboundary water, Single electricity market, Digitalisation, Financing of Infrastructure, Gender
 - Regional sessions to facilitate the validation of projects by RECs
- 13 sectoral Task force meetings with RECS focal points as observers held to enhance quality and fill data gaps in July and August
- 8 Task force meetings for In depth screening, ranking, and arbitration in September and October

Outcome of the PAP2 process


- 242 projects initially received
- 13 projects found not eligible
- 214 hard Infrastructure projects eligible in PIDA Reserve list
- 8 Enabling Env./Soft projects in ICT sector
- 6 projects from SIDS

Mix of Nominal and proportional scoring Criteria

Nominally scored criteria on the basis of performance for criteria

Corridor planning Criteria: Projects should synergize with an existing or planned infrastructure of another sector. (GIS Based)

Gender criteria: Projects under PIDA PAP 2 should propose procurement related actions that could increase women's opportunities to participate in the infrastructure value chain

Economic criteria: Projects should be implemented in countries with the highest need of infrastructure investments (the lowest AIDI scores).

Financial criteria: Projects should present features that are proven to attract private financing (PPI data)

Smart criteria: Projects should display innovative operational approaches or technologically advanced features

Proportionally scored criteria relative to the best performance in the regional pool

Employment criteria: Projects should maximize total job creation in adjoining areas, both during construction and operation. (PIDA Job Toolkit)

Environmental criteria: Projects should minimize amounts of CO2 emissions. (IFIs methodologies)

Rural–Urban connectivity criteria: Projects should impact maximum people living in rural areas (rural population impacted by the project in a 100km radius)



Distribution of 66 Priority projects


Distribution of 66 Priority PAP2 projects

Sectoral distribution of 66 Projects


